He also mentioned the Zebra Crossing markings on the road just past the mini roundabout. The Zebra markings were painted as if it was an authorised crossing but Belisha beacons had not been installed. Cllr. Gardner confirmed that Brookhouse owned the road from the mini roundabout to Tesco. The Clerk confirmed that Highways had adopted the road up to that point. The Chairman thanked Cllr. Hulse for his comments. Proposed by Cllr. O'Neill, seconded by Cllr. Johnson and RESOLVED – that Public Air Time be closed and the meeting reconvened – HS05/18.
